
How to Access the HITS Digital Health (HDH) Learning Management System (LMS)

LEARNING MANAGEMENT SYSTEM

The Learning Management System (LMS) provides easy access to a suite of online learning courses and can be accessed from any browser or device connected to the internet. Your eLearning courses will be assigned to you automatically based on your appointed ClinicalConnect role(s) e.g. Sole Practitioner (Physician) Participant, Privacy Contact, Privacy Auditor and/or Local Registration Authority (LRA). If you hold multiple roles for your organization, you may be assigned multiple eLearning modules.

How to Log into the LMS

step 1 The HITS Digital Health (HDH) Learning Management System (LMS) can be accessed by visiting: <u>https://mylearning.hhsc.ca/HDH</u> using any browser on a computer or mobile device with an Internet connection.



Use your Access Governance System (AGS) username and password to log in.

You are now logged into your learning profile **Dashboard**. The Dashboard contains the **Compliance Overview** section at the top of the page and the **Course Overview** section below. The Compliance Overview displays your assigned eLearning modules that you are required to complete and will track your course progress as shown in the example.




